Introduction

I interned for MaryPIRG's Maryland Student Climate Action Coalition (MSCAC). MSCAC uses grassroots organizing to educate young voters about climate action and lobby for sustainable legislation.

Activities:

Last year, MSCAC drafted the FUTURE Act, a bill aiming make Maryland's public universities carbon neutral by 2035. It is currently in the General Assembly, so many of my tasks centered around raising awareness and support for the bill. One of my main tasks was building profiles on Congresspeople and then meeting with their teams to secure support.

I also worked on various other tasks, such as:

- Helped organize educational and community outreach events
 - Events included: phone banking, climate research panels, climate rallies, writing and compiling testimonials
- Led workshops teaching students how to contact their local representatives
- Compiled voting records
- Created and dispersed educational materials such as infographics and literature
- Supported other coalitions (public health, world hunger, etc.) by attending their events and advocating for important issues

Future Work

- The Coalition is continuing to lobby for the FUTURE Act, which includes raising awareness about climate change and environmental justice.
- They are also advocating for the Recovering America's Wildlife Act, which provides funding for conservation and restoration of wildlife habitats.
- Personally, I have continued my work in environmental policy. I am currently interning for State Senator Will Smith, performing community outreach and helping to advance his campaign.
- This internship helped me to realize that I was more interested in the political aspect than the grassroots organizing aspect.
